- ✓ Launched in August 2018 with nearly 30 courses; 150 active courses today

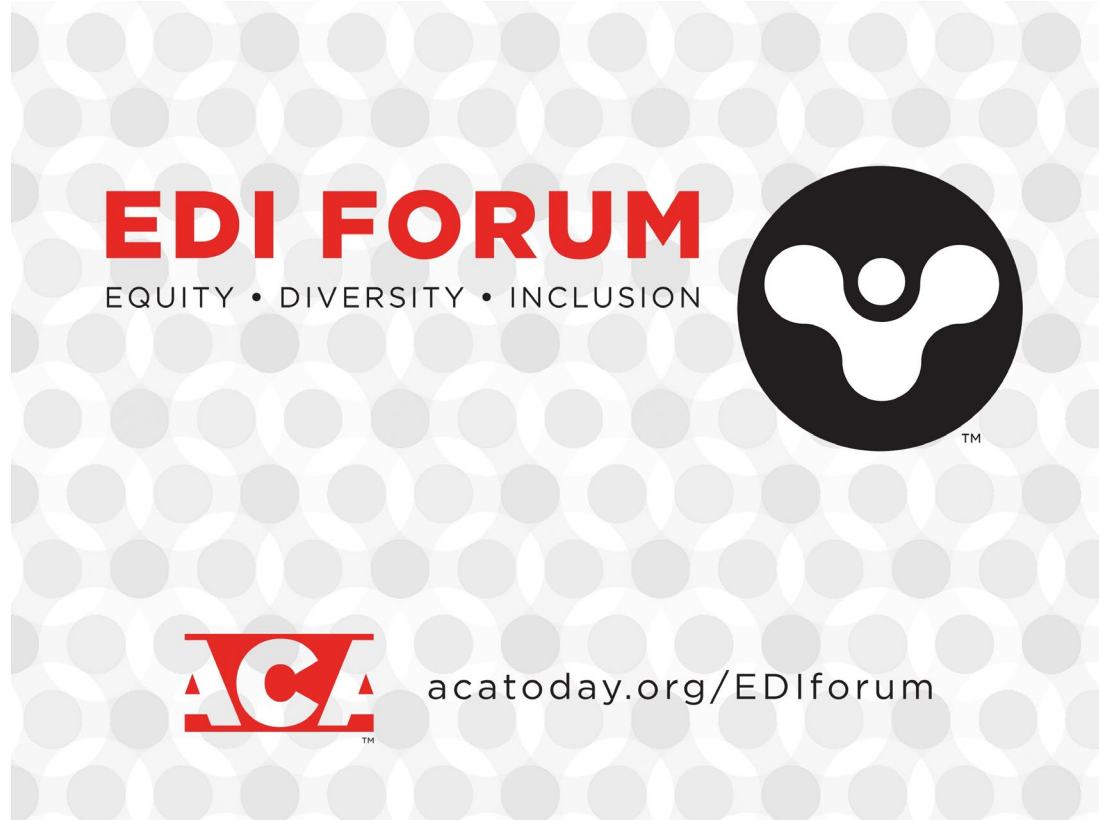
