Program Description

ACA serves an active and engaged participant on several health policy fronts, including physical medicine code development and valuation, coding guidance, payer engagement, and payment reform. The purpose of the Health Policy Fellowship is to support ACA members who are interested in becoming future ACA health policy leaders through gaining a deeper understanding of these issues and providing subject matter expertise on ACA health policy initiatives.

The Health Policy Fellowship increases ACA's capacity to contribute expertise and develop comments for federal rulemaking processes or public comment and enhances ACA's ability to provide representation in roles within external health care organizations, coalitions, or initiatives pertaining to national health policy. By completing this educational program, you will join a cadre of experts who will contribute to the policymaking process in a variety of contexts.

ACA Health Policy Fellowship Program is a year-long course designed to provide exposure to ACA health policy reimbursement and coding activities and develop the next generation of ACA health policy leaders, who will be expected to remain highly active and engaged in the ongoing health policy activities of the Association.

Fellowship Objectives:

- Develop competency and leadership in the creation, revision, and valuation of chiropractic and physical medicine CPT codes through the AMA CPT and RUC processes.
- Observe and develop the capacity to participate in AMA CPT Editorial Panel and RUC meetings.
- Develop a high-level understanding of physical medicine coding and coding guidance, including updating ACA coding resources.
- Understand and learn to strategize on Medicare and third-party payer reimbursement and coverage issues, including the physician fee schedule, Federally Qualified Health Care Center, Community Health Center, and hospital outpatient payment rules.
- Gain knowledge about ACA payer relations subcommittee activities and help innovate on the creation and implementation of new models.
- Serve as content expert to respond to members' inquiries
- Provide education to delegates/state payer liaisons/representatives monthly or quarterly relative to regional payer relations issues.
