ACA-PAC CHAIRMAN REPORT

I want to thank all who contributed to the ACA-PAC in 2023!

Through our PAC we are able to help elect our key legislative champions to Congress so they can keep up the fight for us. This is why I am asking you to take a look at what you can do to help us in 2024.

2024 is an election year making it critical for us to have a strong PAC. The outcome of elections does impact the Chiropractic profession and our practices in dramatic ways. We need chiropractic supporters in key positions of power and influence on both sides of the aisle.

We were able to contribute \$134,500 to 52 pro-chiropractic candidates in 2023. It is critical to have candidates in Congress who know and understand the benefits of Chiropractic physicians.

One of our major legislative focuses has been on the passage of The Chiropractic Medicare Coverage Modernization Act. This would allow Medicare beneficiaries access to the chiropractic profession's broad based, non-drug approach to pain management, which includes manual manipulation of the spine and extremities, evaluation and management services, diagnostic imaging and utilization of other non-drug approaches that have become an important strategy in national efforts to stem the epidemic of prescription opioid overuse and abuse.

Thank you again for your contribution in 2023. I hope you will continue your support in 2024, and even join me at one of the Capitol Club levels. While your participation is completely voluntary, you know how critical it is for us to continue to build a pro-chiropractic Congress - which benefits our practices and patients.

ACA-PAC contributed \$10,500 to Republicans and \$9,000 to Democrats running for the U.S. Senate.


U.S. HOUSE
